SUBJECT: Appointment of Alternate Public Member to Commission

The Commission will receive a report identifying the three candidates for the alternate public member seat and receive the subcommittees recommendation. The Commission will consider and potentially take action on the appointment. This appointment requires a majority vote of the Commission, and the affirmative vote of at least one county, city, and

district member.

#### **BACKGROUND**

The Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 states the composition of Local Agency Formation Commissions (LAFCos) shall generally include seven regular commissioners consisting of two county members, two city members, two special district members, and one public member. There are also alternates for each category. The Commission serves as the appointing authority for the regular and alternate public members, which are appointed by the other regular members of the Commission (county, city, and special district).

In March 2022, a subcommittee was appointed including one county, one city, and one special district member in order to review any applications that were received for the open alternate public member seat. However, no applications were received until January/February 2023. The subcommittee was reappointed in January 2023 to include Commissioners Lake, Losey, and Madrone.

#### **DISCUSSION**

The alternate public member seat previously held by Skip Jorgensen is currently vacant. Three applications were received and reviewed by the public member selection subcommittee. The three candidates include former commissioners Stephen Avis, Virginia Bass, and Gordon Johnson. The subcommittee has chosen to not conduct interviews at this time and is recommending Gordon Johnson be appointed to the Commission. Each candidate was notified of the subcommittees recommendation and was invited to attend the Commission's March meeting. The Commission is invited to discuss this item and interview or otherwise ask questions of any attending candidates prior to taking action on appointing a new alternate public member to LAFCo.

#### **RECOMMENDATION**

Staff recommends the Commission consider the subcommittee's recommendation for Alternate Public Member, obtain public comment, and appoint a new Alternate Public Member to the Commission. This appointment requires a majority vote of the Commission, and the affirmative vote of at least one county, city, and district member. Alternatively, the Commission may choose to continue this item to the next regular Commission scheduled for May 17, 2023.
