**SUBJECT:** **Status of MSR Preparations**  
The Commission will receive a report summarizing activity on MSR/SOI Updates including a FY 2020-21 MSR workplan and schedule.

### BACKGROUND

The Cortese-Knox-Hertzberg Local Government Reorganization Act directs Local Agency Formation Commissions (LAFCos) to regularly prepare municipal service reviews (MSRs) in conjunction with establishing and updating each local agency's sphere of influence (SOI). The legislative intent of MSRs is to proactively assess the availability, capacity, and efficiency of local governmental services. MSRs may also lead LAFCos to take other actions under their authority, such as forming, consolidating, or dissolving one or more local agencies in addition to any related sphere changes. As part of the Commission's annual budget process, a work plan for MSR completion is adopted.

### DISCUSSION

Following is a summary of FY 2020-21 MSR Updates.

#### Humboldt Bay Municipal Water District MSR and SOI Update

In process; HBMWD is a wholesale water supplier that provides water to many agencies throughout the Humboldt Bay Region. The District is looking into preparing a feasibility study for extension of water service to the Trinidad Rancheria. LAFCo staff recently received information from the District and will begin drafting the MSR in the next few months.

#### Big Lagoon CSD MSR and SOI Update

#### Willow Creek CSD MSR and SOI Update

In process; Willow Creek CSD provides water, parks and recreation, and street lighting to Willow Creek along Highway 299. The District is also working towards providing wastewater service to the area. LAFCo staff received information from the District and is in the process of finalizing an administrative draft for District review.

#### Patrick Creek CSD MSR and SOI Update

Completed. MSR and SOI updated was adopted at the November 2020 meeting.

#### McKinleyville CSD MSR and SOI Update

In progress; McKinleyville CSD provides four distinct services to the unincorporated community of McKinleyville. Services include potable water, wastewater collection and

treatment, parks and recreation services, and street lighting. LAFCo staff has received information from the district and is in the process of finalizing an administrative draft MSR for District review.

Upon consideration of the remaining FY2020/21 MSRs and budget, staff has chosen to push the remaining MSRs (Riverside CSD, City of Eureka, and Phillippsville CSD) to the next fiscal year.
