



## **APPLICATION: ALTERNATE PUBLIC MEMBER**

The Humboldt Local Agency Formation Commission (LAFCo) is accepting applications from interested community members to serve as the Alternate Public Member on the Commission. The Alternate Public Member participates in Commission meetings and serves as a voting member in the absence or disqualification of the Regular Public Member. The appointment is for a four-year term ending June 30, 2030.

### **Eligibility**

Applicants must be residents of Humboldt County, available to attend regular Commission meetings, and have a general understanding of LAFCo responsibilities. Applicants may not be an officer, either elected or appointed, or employee of the county, any city, or special district in the county, or serve on a board or commission with authority to make advisory or final decisions related to land use or the provision of services. The position is considered a public office and requires annual financial disclosure filings (Form 700), which are maintained by LAFCo in accordance with the California Fair Political Practices Commission regulations.

### **Time Commitments**

LAFCo meetings are typically held six times per year at 9:00 a.m. on the third Wednesday of odd-numbered months, unless otherwise scheduled. Meetings are held in the City of Eureka Council Chambers (531 K Street, 2<sup>nd</sup> Floor, Eureka). Special meetings and subcommittee meetings may be scheduled as needed. All members, including alternates, are expected to regularly attend meetings. Commissioners receive a \$20 stipend and mileage reimbursement for each meeting attended.

### **Appointment Process**

The Alternate Public Member position is appointed by the Commission. Appointment requires a majority vote of the Commission, including at least one affirmative vote from the County, City, and Special District members. The Commission may designate a subcommittee to review applications, conduct interviews, and provide a recommendation for the appointment.

### **Deadline for Applications**

The Alternate Public Member position will remain open until filled. Applications received by June 19, 2026 at 5:00 p.m. will be considered for potential appointment at the July 15, 2026, LAFCo meeting. Selected applicants may be contacted for additional information and/or invited to participate in an interview prior to appointment.

Cover letters, letters of recommendation, and/or resumes are not required but will be accepted and should be submitted with the completed application.
